Effective May 1st, 2026

The following user charge rate schedule shall be assessed to all persons, firms, corporations, companies, institutions, and organizations for water furnished and supplied by the City of Trenton, Missouri, or any department thereof.

A separate minimum charge shall be made for each meter serving an individual customer.

WATER TAP FEES:

1" or less	\$ 98.15 per tap plus materials
2" or 4"	\$ 199.30 per tap plus materials
6"	\$ 393.50 per tap plus materials

Rates above do not include the Missouri DNR Drinking Water Primacy. This fee is assessed by DNR annually and charged to customers as a separate line item on the utility bill.

**Sales tax on water is as follows: Residential – 3%, Residential outside city limits – 1.5%, Commercial – 8.35%, Commercial outside city limits – 5.725%
100% Manufacturing tax – exempt from taxes.**

Insufficient check charge - \$30.00

Reconnect fee for disconnection - \$30

Charge to send unpaid balance to collections - \$20.00

The new waters rates established herein shall become effective with usage beginning May 1st, 2026, and on bills posted on or after May 31st, 2026.
